MEMORANDUM

Subject: Sanction of mobilization advance @ 10% of the tendered amount in projects of bridges / ROBs / flyovers projects.

It has been observed that for the bridge / ROB / flyover projects, the contractor has to mobilize a lot of equipments etc. on site before the work can be taken up. As of now, the Department is giving mobilization advance in such cases on case to case basis with the concurrence of Finance Department.


The matter has been under consideration for some time, and now the Governor has been pleased to allow mobilization advance to the agency selected for construction of bridge / ROB / flyover projects on the following conditions:-

1. The mobilization advance @10% of tendered amount at 10% simple interest may be sanctioned to the contractor on specific request as per term of the contract,
2. The mobilization advance shall be released only after submission of an unconditional Bank Guarantee from a scheduled bank by the contractor for the amount of advance and interest, which will remain valid for the contract period,
3. The mobilization advance together with interest on the advance shall be recovered from running account bills of the contractor, and
4. Other terms and conditions of General Conditions of Contract, 2014 of CPWD Manual.

This has concurrence of Finance Department, Group T vide their U.O. No.Group T/2015-2016/0163 dated 05.06.2015.
